- No RTW closure data available prior to PBAS, which was introduced in 2002.
- 2. Labour Market Re-entry (LMR) Program between 2002 and 2010 LMR referrals closed as "unemployable" were captured using closure code 18.

 3. Work Transition (WT) Program between 2011 and May 2014 WT referrals closed as "unemployable" were captured using closure code 18.

- 4. Work Transition (WT) Program between May 2014 and May 2018 WT referrals closed as "unemployable" were captured using closure code 55.

 5. Return to Work (RTW) Program between May 2018 and July 25, 2021 code 55 was used to capture "unemployable" cases, however this code was also used for cases where the plan was deemed not cost effective, as well as cases where the worker opted for self-directed plan, as well as cases where services were completed to improve where the pair was deemed not consider the construction, as went as takes where the whole object to serious injuries. Therefore we cannot separate the multiple scenarios and isolate only those determined to be "unemployable" during this period of time.

 6. Return to Work (RTW) Program - starting July 26, 2021 closure code 56 has been used exclusively for "unemployable" cases.
