NEL awards are compensation paid to a worker who suffers a permanent impairment as a result of an injury or illness that occurred after January 1, 1990 and is based on the severity of the permanent impairment. All injury/illness types (lost-time and no lost-time) are included in this measure. Non-Economic Loss cannot be assessed until a worker has reached maximum medical recovery (MMR). As such NEL awards are typically awarded within 3 years of incident and this measure reports the proportion of workers who have received an award by this point.
4. Second Injury and Enhancement Fund (SIEF) by "SIEF Decision Date" between January 1, 1998 and December 31, 2024.
5. SIEF is a cost relief for Schedule 1 employers where all or part of the costs associated with a Claim (compensation and health care costs) may be transferred from a Schedule 1 employer to this fund if: 1) A prior disability caused or contributed to the compensable accident, or: 2) The period resulting from an accident becomes prolonged or enhanced due to a pre-existing condition.
