- 5. As it pertains to the Moving Defendants, the underlying action does not relate in any way to contracts made in the province.
- 6. None of the Moving Defendants consent or attorn to Ontario's jurisdiction.
- 7. No reasonable grounds exist for the Court to assume jurisdiction.
- 8. The principles of order, fairness and judicial comity all suggest the Court should grant this motion and dismiss the action against the Moving Defendants.
